

DECLARATION OF INDEPENDENCE II

JULY 4, 2026 - 250YR ANNIVERSARY



A Declaration of Independence and RESTORATION of united States of America,

In the Course of human events, it has become necessary for us as citizens of the United States to proclaim once more the inalienable rights to which the Laws of Nature and of Nature's God entitle us and to outline the abuse of these rights that our current national government is propagating against them, to a listening world.

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.

That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed,

That whenever any Form of Government becomes destructive of these ends it is the Right of the People to alter or to abolish it, to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness.

And in the case of the citizens of the current United States, to RESTORE our government to its proper boundaries and functions.

When a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce the citizens to absolute Despotism, it is their right, it is their duty, to throw off such Government, or to RESTORE their government to provide once again Guards for their future freedom and security.

The history the Current National Government is a history of repeated usurpations and abuses, all having in direct object the establishment of an absolute tyranny over the States and their citizens.

To prove this, let the facts be submitted to a candid world:

The National Government has:

- Overruled legitimate laws
- Selectively not enforced laws
- Arbitrarily made law by decree
- Suspended laws
- Passed laws in secret
- Passed laws at unusual times and places
- Approved judges with the design to overrule state laws
- Used public money to pay off officials
- Imposed taxes without consent
- Usurped the power of state governments
- Invaded our privacy through domestic spying
- Forced individuals citizens to violate their conscience
- Hired additional government workers to harass the people
- Protected multitudes of public officials from the punishment of their felonies, lying, and coverup.
- Derided, mocked, and chided those who have legitimate concerns
- Harassed those who have resisted the tyranny
- Caused jealousies, covetousness, strife amongst the citizens
- Sued states for passing laws
- Ruined the value of the peoples money

- Illegitimately shut down small businesses and churches
- Legislated through use of Executive Orders and Unconstitutional degrees
- Legislated through bureaucratic deep state
- Persecuted people of faith
- Encouraged rioting and mobs
- Opened our borders to invasion and facilitating the invasion
- Allowed the killing of our people through the invasion of drugs
- Surrendered our children to groomers and child molesters in public schools
- Destroyed the definition of women and their sports
- Destroyed the biological reality of male and female through executive order
- At every turn usurped power from state and local governments
- Censored the American people through government collaboration with social media companies
- Forced a medically experimental shot on tens of millions of Americans
- Turned federal agencies against the people and protecting bureaucrats
- Violated almost 100% of the Bill of Rights

In every stage of these Oppressions, We have Petitioned for Redress in the most humble terms: Our repeated Petitions have been answered only by repeated injury. A National Government, whose character is thus marked by every act which may define a tyrant is unfit to be the ruler of a free people.

WE DECLARE

We, therefore, as citizens assembled in prayer, remembering our covenants and appealing to the Supreme Judge of the world for the rectitude of our intentions, do solemnly publish and declare,

That our United States ought to be FREE ONCE AGAIN and that the US CONTITUTIONAL SYSTEM should once again be RESTORED. That the federal government should be limited to its 18 enumerated powers given to Congress, that the Executive branch and the Supreme Court should once again be limited to their jurisdictional boundaries.

That the 50 States should ONCE AGAIN take up their mantle and vast powers to govern as 50 individual state republics and that citizens should again take responsibility for their local governments and for their own self government in their communities, their local associations and their families.

And for the support of this Declaration, with a firm reliance on the protection of **Dvine Providence,** we mutually pledge to each other our **Lives, our Fortunes and our sacred Honor.**
